

## **Table Tennis Ireland Garda E-Vetting Process**

- 1. The Applicant completes "NVB 1 Vetting Invitation Form"
  - a. Please note the form must be completed using **BLOCK CAPITALS**
  - b. The Applicant must complete Sections 1 and 2 of the form
  - Section 3 should be left blank (to be filled in by Nominated Person for Table
     Tennis Ireland at Irish Sport HQ)
  - d. If the applicant is under 18yrs old, they must also submit "NVB 3
     Parent/Guardian Consent Form" which must be signed by a parent/guardian
  - e. Applicant must review the "100 Points Document" and choose which documents they are submitting to meet the minimum of 100 points. Copies of the documents must be submitted with "NVB 1 Vetting Invitation Form"
    - i. For example, Irish driving licence (80pts) and Gas utility bill (35pts)
  - f. Please note that as of **December 2019**, we can <u>no</u> longer accept **Public** Services card as a document
- 2. The cost of processing an application is €15 for affiliated members of Table Tennis

  Ireland and €45 for non-members
- 3. Payments can be made by the following methods:
  - a. Members can log into GoMembership, go to the "Events & Courses" section and choose "Garda Vetting Request" under featured events
  - b. Bank transfer
    - i. Applicants should include their "Name" in the "Reference" field when making an EFT

- 4. Applicant must submit the completed "NVB1 Vetting Invitation Form" along with copies of the I.D. documents to <a href="mailto:manager@tabletennisireland.ie">manager@tabletennisireland.ie</a> or by post to the following address:
  - Garda Vetting, Table Tennis Ireland, Irish Sport HQ, Sport Ireland National
     Sports Campus, Blanchardstown, Dublin 15, D15 DY62
- 5. Once the application has been processed by the Nominated Person for Table Tennis Ireland, the Applicant will receive an email from the National Vetting Bureau with a link and instructions on how to complete the e-vetting process. Please note that the link in the email will expire after **30 days**. Applicants are encouraged to complete the process as soon as possible. The link can be re-activated once it expires, but the applicant will have to pay the vetting fee again
- 6. Once the vetting process is completed, the National Vetting Bureau will email the "Disclosure letter" to the Nominated Person for Tale Tennis Ireland, who will forward a copy to the applicant
