Tournament Regulations & Information

1. Every entrant must be affiliated to the ITTA Ltd.
2. This event is **not** an Open tournament and is confined to players who live or were born in Ireland, or hold an Irish passport.
3. Matches will be played in accordance with the rules & regulations of the ITTA.
4. Completion and submission of this entry form signifies agreement by the entrant to the conditions of the competition including the variations from the ITTF requirements.
5. All competitors will be required to umpire.
6. The final order in a group shall be determined as per ITTF Regulations 3.7.5 for group competitions except that where a player concedes a match he/she shall receive -3 group points.
7. Competitors born in **Under 11 Hopes on or after 1st January 2011, Under 13 on or after 1st January 2009; Under 15 on or after 1st January 2007; Under 19 on or after 1st January 2003.**
8. The Tournament Committee reserves the right to alter the programme, format or venue; to cancel any event; to reject or regrade entries; and to restrict admission to the tournament venue.
9. Joola 3* Plastic Balls will be used.
10. Doping control tests may take place, more information on doping available on our website: <https://tabletennisireland.ie/anti-doping/>.
11. All competitors must report to the control table on arrival and must not leave the venue while still in the competition without first obtaining permission from the Referee.
12. Competitors will not be allowed to glue up within the confines of the playing venue. "Playing Venue" means the whole establishment in the playing building and the grounds where the playing building stands, which contains the doorway, the parking lot and related facilities.
13. The Referee's decision shall be final on points of law or on any question arising not provided for in these regulations or in any dispute as to the interpretation thereof. Decisions on points of fact by an umpire or assistant umpire appointed by the Referee shall be final.
14. Play throughout will be on Joola Tables, using Joola 3* Plastic Balls.
15. Time-outs allowed for U/13, U/15 and U/19 comp. Nominated coaches only for U/13 event. No coaching U11 players.
16. **Format of Events:** All Singles events will be played on a Round Robin format for the first round. The top 2 in each group will progress to second round groups. The winners of the second round groups will progress to the knockout stages. There will be a plate competition in each event for players eliminated in the first round. **In any event where there are insufficient entries it may be necessary to scrap second round groups and proceed directly to knockout.**
17. The ITTA has a policy on the use of photographic and video recording equipment at ITTA events, and permission for the use of such equipment must be granted by the Referee or Organising Committee. All participants accept that photographs or other recorded images taken on behalf of the ITTA may be used in connection with the promotion of ITTA events and activities, unless requested otherwise in advance by the participant or their parent/guardian. Events may be live streamed.
18. The Irish Table Tennis Association including its Branches, Leagues, Committees and others who are affiliated to the Association (hereinafter "the ITTA") reserves the right to cancel, postpone, discontinue or abandon any event or tournament at any time and for any reason whatsoever (hereinafter "an occurrence"). Where such an occurrence arises, the liability of the ITTA shall be limited to a maximum of a refund of the entrance fees paid by the entrant. The ITTA does not accept responsibility or liability for any associated and/or consequential losses (including, but not limited to travel or accommodation expenses), whether monetary or otherwise, incurred by the entrant. The ITTA does not accept responsibility or liability in respect of any costs, expenses or other losses incurred by spectators, officials, coaches, members of the media or other attendees of any event or tournament.
19. All players, Coaches, Club Officials and Volunteers must comply with TTI guidelines on Social Media. Violation of any of these guidelines may result in disciplinary action.
20. No entry will be accepted unless the following undertaking is signed.
 1. To observe the regulations.
 2. To abide by the decision of the Referee and Organising Committee.
 3. To fulfil the schedule of play arranged for me unless prevented by circumstances beyond my control and accepted as such by the Referee.
21. Acceptance of these Regulations is a condition of entry.
22. **Table Tennis Ireland require dates of birth for all junior players for the national affiliation database.**
